



Examples of our 2019 international action: strengthening the resi-lience of peasant families and supporting rural organisations

Value chain support in the Central African Republic (CAR) for ACF

Ongoing since 2019, Alexandre VIGOT.

Since May 2019, we support Action Contre la Faim (ACF) teams in a project that aims to strengthen rural resilience and support producers and agro-pastoral value chains through the development of local capacities and the creation of jobs in the northern regions of CAR. This project is financed by the Bêkou Fund (EU), which contributes to the stabilisation and reconstruction of CAR by better linking reconstruction and development programs with the humanitarian response. This two-year project is being carried out by a consortium of several NGOs. We began our support by training the teams in the value chain approach. This enabled us to draw up an action plan. Tero now supports ACF teams in its implementation, particularly with respect to the honey, sesame and groundnut value chains.








FEEDBACK FROM OUR PARTNER : ACF

«TERO and Action contre la Faim have initiated an original way of working together on agricultural value chains developments within the framework of a project to strengthen rural resilience in the Central African Republic financed by the European Trust Fund for the Central African Republic (Békou). TERO's support to our teams in Bossangoa goes far beyond traditional expertise: TERO is accompanying us throughout the project, carrying out 4 field missions and remote support. Involved from the initial assessment of agricultural value chains, our teams have seen their capacities strengthened throughout the project. This form of support is highly appreciated, as it maintains strong ownership of the project by our teams. It has helped demystify a number of concepts that seemed vague at the outset. As our project manager sums up: «TERO's support has led us out of the fog and allows us to move forward with a clear vision.»

Final evaluation of the SECAL project in Haiti for AFD

From September to November 2019, Grégoire ETESSE.







TERO carried out the evaluation for AFD of a SECAL food security project that had been in place for 5 years and co-financed by AFD and the EU. Following Hurricane Matthew, the project had evolved and emergency funds were released. Despite the political crisis in the country, TERO was able to carry out a field evaluation phase in both intervention areas. The project focused on family farming and access to irrigation. In discussions on working with farmers, TERO was able to take into account the disparities in situations. Its references in Haiti and its experience enabled it to provide teamwork that was both effective and clear in terms of avoiding the emergence of potential inconsistencies within the project. This evaluation benefited from previous experiences in Haiti and in particular from TERO's network of local actors.



Definition of proposals to support the social and solidarity economy in Ecuador - Consultancy funded by the EU

From February to May 2019, Sylvain BLEUZE.

Following the earthquake that strucked Ecuador in 2016, an Economic Reconstruction Committee was set up and supported by the EU, among others. TERO was then called upon to assess the possible causes of the limited development of the social and solidarity economy (SSE) in the agriculture, fishing and community tourism sectors in several Ecuadorian provinces. In addition to the assessment, TERO proposed financial and management mechanisms to the organisations... Indeed, the sustainability of family farming depends on the conditions of their access to markets, hence the need for management tools adapted to SSE organisations. The TERO team composition, the opportunity to benefit from an international perspective, including recognised French know on SSE, as well as the values and proposals in support of family farming, were appreciated during this mission.

Expertise in France: supporting concrete approaches to food transition in territories

Out-of-home catering in the Aix-Marseille Region

More and more communities are looking to relocate their food networks. This is particularly the case for collective catering, which is seen as a lever for developing local agriculture and giving the greatest number of people access to better quality food. In 2019, TERO has supported several projects in this area: As part of the Territorial Food Project carried by the Aix-Marseille-Provence Métropolis and the Pays d'Arles Rural Territorial Equilibrium Center, for example, TERO has quantified and qualified public school demand and has run several workshops with municipalities in order to identify



their needs and promote experience sharing. TERO has also helped launch a platform of organic producers, Manger Bio en Provence, dedicated to supplying the collective catering sector by carrying out an opportunity study and identifying establishments and producers interested in this initiative. A further example: the Urban Community of Greater Avignon asked TERO to develop and implement its Territorial Food Project (PAT), for which the catering industry is one of the 4 major lines of action.

Agricultural Policy Belledonne-Grésivaudan FRANCE, from February to September 2019, Charlène NICOLAY, Frédéric SOULA and Gilles MARECHAL

The objective of the mission was to assist in the development of future agricultural and food strategies for the three clients: the Grésivaudan and Cœur de Savoie communes groupings, and the association for the development of the Belledonne mountain chain. Initially focused on the economic impact of agriculture on the territory, the mission made possible to widen the scope of food system analysis and to approach the importance of agriculture and food for these territories in a more cross-cutting way: maintaining the openness of mountain landscapes, coexistence of pastoral and touristic activities, agroecology, climate change, resilience and social accessibility.



The public policy planning dimension of this assignment was at least as important as the assessment itself: presentations to local councils, specifying the action plan's evolution over several years, budgeting actions... were all appreciated by the stakeholders. The mission led to ambitious political and budgetary choices on the part of the two communes groupings.

The certification activity (documentary or field evaluation) continued its development in 2019. It focused on certification systems in line with TERO's values and vision, following a logic of complementarity, limiting competition with existing labels and certifiers, and at the service of cooperatives and social and solidarity economy stakeholders engaged in highly committed fair trade labels.

TERO has continued to strengthen its activity as a certifier for the Peasant Producers' Symbol (SPP). With a growing team of 12 independent employees who are geographically close to the certified cooperatives, we have provided 9 services in 2019:



- in 16 countries (South Africa, Burkina Faso, Burundi, Cambodia, Côte d'Ivoire, France, Ecuador, Ethiopia, Haiti, India, Indonesia, Madagascar, Democratic Republic of Congo, Sri Lanka, Togo, Tunisia); - to 29 Small Producer Organisations; - to 3 intermediaries, processors and/or exporters;

- to 9 final buyers in France;

- to 12 small buyers, linked through a simplified procedure to an end buyer.

In addition, by partnering with iDterritoire for expertise in fair and solidarity tourism, TERO conducts independent evaluations on behalf of the Association for Fair and Solidarity Tourism (ATES). The ATES has created and supports the "Garantie Tourisme Equitable et Solidaire" label. ATES tour operators, players in tourism in France, are all committed to making travel a lever for development and solidarity. They offer more than 260 trips in nearly 59 countries. TERO has evaluated 2 tour operators in 2019. Our exchanges with label holders (SPP GLOBAL and ATES) enable them to benefit from our feedback from the field and allow us to propose improvements to their criteria, procedures and tools.

2019 Financial Report: consolidation before a period of uncertainty

The 2019 financial year is profitable, generating a net result after tax of +29 k€ (+18 k€). Turnover is growing significantly (+184 k€, +28%) and exceeds forecasts. It reflects the increase in the success rate of responses to calls for tenders and the robust implementation capacity of our members and salaried team. Added value is clearly rising, but not its proportion. The operating result is 32 k€ and the operating margin increases from 2.3% of sales in 2018 to 3.8% in 2019. This result includes the offsetting by TERO of the CO2 emissions of its 2019 international trips by co-financing community and peasant reforestation actions supported by InterAide in Madagascar. However, the 2020 budget is already challenged by the covid-19 pandemic. Though certification and assignments in France are budgeted to increase, international expertise will have difficulty reaching its 2019 level and initial forecasts. The current necessary expenditure adjustments include a reduction in personnel costs.

In financial terms, Tero has strengthened its equity in 2019 and its working capital requirement are increasing as its financial activity develops.

On the liabilities side, permanent capital amounts to 120 k€ (+43 k€), thanks to the subscription of new shares (+13 k€) and the surplus from 2018 and 2019. Resorting to borrowing is on the decrease. Trade payables at the end of the year are stable. Tax and social security debts are on the rise with the reinforcement of the technical team.

DISTRIBUTED DIVIDENDS

In accordance with the provisions of Article 243 bis of the French General Tax Code, the Board notes that no dividend has been paid out over the last three financial years.

SIGNIFICANT EVENTS SUBSEQUENT TO THE END OF THE FINANCIAL YEAR To date, no significant event has occurred since the end of the 2019 financial year.

With respect to assets, operating receivables are up sharply due to late payments from major customers at the end of 2019, despite the implementation of tools for monitoring and payments following of customers. From a functional point of view, TERO's working capital at the end of 2019 amounts to 137 k€, rising less rapidly than working capital requirements (95 k€). TERO's available funds at the end of the fiscal year are decreasing. Tero pursues its policy of financial independence, strengthening its equity capital, and carefully managing its cash flow, as required for the development of its business.

Environmental and social commitments at the heart of TERO's actions

In 2019, we reaffirmed our support to family and smallholder farming, as well as to agro-ecological and food system transition at a territorial level. This commitment is a beacon within the framework of our assignments. - We carefully select missions, leaving others to support agricultural and food systems that favour industrial agriculture and have potentially negative social and environmental impacts. We carefully examine the sincerity and coherence of the approach when responding t to requests from private companies, and strive to offer consultancy services adapted to companies engaged in social and environmental systemic reform.

- We have a strong social policy: the differences in salaries for permanent contracts within our technical team are less than 2; the differences in remuneration between consultants are limited; we have promoted young people, women (the current technical team is at parity), and internal training.

- We are developing in-depth relationships with civil society actors and the French and international cooperative movement, in the choice of assignments and in the establishment of medium-term strategic partnerships. - We maintain strong environmental standards at all levels: support for projects aimed at agro-ecological transition, limitation whenever possible of air transport, and offsetting of carbon emissions linked to international travel.
